QUALIFICATIONS, EXPERIENCE AND AGE LIMITS FOR INITIAL APPOINTMENT.

- 4. A candidate must possess the educational qualifications and experience and must be within the age limits mentioned against the post in the Schedule to this notification, provided that:—
 - (i) "Experience" means, the experience gained in a regular full time paid job after attaining the prescribed basic qualifications. Period spent on studies whether inside or outside the country, during service except for M. Phil or Ph. D. in the relevant field will be excluded from the total length of experience.

- (ii) The maximum age limits will be relaxed up to the age of 55 years, whichever applicable, for appointment to all posts in the Federal Government as follows:—
 - (a) by three years in the case of candidates belonging to the Scheduled Castes, Buddhist, Community, recognized tribes of the Tribal Areas, Azad Kashmir and the Northern Areas.
 - (b) by not more than ten years in the case of Government servants who have have completed at least 2 years continuous Government service on the closing date—for submission of applications.
 - (c) by ten years or the number of years served in the Armed Forces, whichever is less, in the case of released or retired Officers, personnel of the Armed Forces of Pakistan.
- (iii) Eligibility of candidates shall be reckoned as on the closing date fixed for the submission of applications, in accordance with the Recruitment Rules and the Instructions issued by the Government and the FPSC.

APPOINTMENT BY TRANSFER

5. Appointment by transfer shall be made by selection from amongst the persons holding appointment on a regular basis under the Federal Government in the same basic pay scale in which the post to be filled exists, provided that the persons concerned possess the qualifications and experience prescribed for initial appointment or promotion to the post concerned.

PROBATION

- 6. Person appointed by promotion or initial appointment or transfer shall be on probation for a period of one year. This period may be curtailed for good and sufficient reasons to be recorded, or if considered necessary, it may be extended for a period not exceeding one year as may be prescribed at the time of appointment. Appointment on probation shall be subject to the provisions of section 6 of the Civil Servants Act, 1973.
- 7. This Notification issued with the concurrence of the Establishment Division vide Office Memorandum No. 7/3/94-R. 6., dated the 5th June. 1995 and FPSQ vide their letter No. F. 12-6/95., dated 20th September. 1995, respectively.
