N O T I F I C A T I O N

-- In pursuance of sub-rule (2) of rule 3 of the Civil Servants (Appointment, Promotion and Transfer) Rules, 1973 the following method, qualification and other conditions are laid down for appointment to the post of Printing Officer (Grade-17) in the Ministry of Law and Parliamentary Affairs (Law Division), hereinafter referred to as "the post".--

1. Method of appointment. The post shall be filled by promotion. If no suitable person is available for promotion, the post shall be filled by initial appointment.

2. Condition for Promotion.— Promotion to the post shall be made by selection from amongst the persons who hold in the Law Division the post specified in column (1) below:—

3. Qualification, Experience and age limit for initial appointment.

A condition for initial appointment shall be a citizen of Pakistan possess the educational qualifications and experience, and be within the age limit, mentioned in the schedule to this notification:

Provided that the age limit is relaxable in case of Government servants:

Provided further that the maximum age limit shall relaxable by 3 years in the case of candidates belonging to Scheduled Castes, Bhudhist Community, recognised tribes of the Tribal Areas, Azad Kashmir, and Northern Areas (District of Gilgit, Ghizer, Skardu and Ghamche and Diamir) in accordance with the instructions issued by the Establishment Division, from time to time.

4. Probation. Persons appointed by initial appointment, promotion or transfer shall be on probation for a period of one year. This period may be curtailed for good and sufficient reasons to be recorded, or if considered necessary, it may be extended for a period not exceeding one year as may be specified at the time of appointment. Appointment on probation shall be subject to the provisions of section 6 of the Civil Servants Act, 1973 (LXXI of 1973).

5. This notification issues with the concurrence of the Establishment Division vide their office memorandum No. 19/4/76 -R5., dated the 25th August, 1982.

METHOD OF APPOINTMENT

2. The method of appointment to the posts shall be as under:—

Provided that if no suitable person is available for promotion, the post or posts reserved for promotion shall be filled by initial appointment and failing that by transfer.

CONDITIONS FOR PROMOTION

3. Promotion to the posts in column (2) of the Table below shall be made by selection from amongst the person who hold the posts specified in column (3) thereof on a regular basis and fulfill the conditions of eligibility as prescribed in column (4)—

QUALIFICATIONS, EXPERIENCE AND AGE LIMIT FOR INITIAL APPOINTMENT

4. A candidate for initial appointment must possess the educational qualifications and experience and must be within the age limits as mentioned against the posts concerned in the Schedule to this Notification, provided that—

- (i) "experience", means post-qualification experience gained in a regular full-time paid job after obtaining the required qualification;
- (ii) The period spent by a candidate in obtaining degree of M.Phil or Ph.D in the relevant field shall be treated as practical experience up to a maximum period of two and four years respectively for the purpose of initial appointment, provided that—

- (a) A candidate who has obtained the degree of M.Phil or Ph.D during service shall not be entitled to a double benefit of counting the said period as service towards experience prescribed for the post; and
- (b) This concession shall not be available for the posts for which the prescribed qualification is M.Phil or, Ph.D; as the case may be.
- (iii) the maximum age limit shall be relaxed in respect of the candidates specified and to the extent indicated in the Initial Appointment to Civil Posts (Relaxation of Upper Age Limit) Rules, 1993 as amended from time to time; and
- (iv) Eligibility of candidates shall be reckoned as on the closing date fixed for submission of applications in accordance with this Notification and the instructions issued by the Federal Government and the Federal Public Service Commission from time to time.

APPOINTMENT BY TRANSFER

5. Appointment by transfer shall be made by selection from amongst the persons holding appointment on regular basis under the Federal Government in the same basic pay scale in which the post to be filled exists, in terms of Civil Servants Act and Civil Servants (Appointment, Promotion and Transfer) Rules, 1973.

PROBATION

6. Persons appointed by initial appointment or promotion or transfer shall be on probation subject to the provisions of the Civil Servants Act, 1973 and rules made thereunder.

This Notification issues with the approval of the Establishment Division contained *vide* its OM No. 7/7/97-R-6 dated 23-09-2019 and with the concurrence of FPSC contained *vide* its letter No.12-35/2019-RR, dated 30-11-2020 and supersedes Notification No.1(4)/81-AI, dated 19-10-1982 of the post of Printing Officer (Grade-17) Ministry of Law & Parliamentary Affairs.
